- The Alliss grant is an opportunity grant, designed to help adult learners begin or return to college. To qualify, students must meet the Alliss grant requirements and may be eligible to receive one course (up to five credits) free (not including application or additional fees, or books) or
The college may augment Alliss program funding with additional support provided for adult learners. The augmented program (Adult Learner Grant) provides payment of tuition up to 6 credits (not including application or additional fees, or books) for credit-based courses.
Course(s) selected must apply to the student's declared degree.
Students may receive the Alliss Grant or the Adult Learner Grant, but not both.

This form must be submitted to the Records Office IN PERSON at the time of your application and registration for courses. Grant requests will not be accepted after initial registration is complete. Additional fees must be paid at the business office when you register. The grant is not reusable. If you withdraw from a course, you may not use the grant again.

The college supports all learners. Adults interested in pursuing learning opportunities at Anoka-Ramsey may meet with an academic advisor to explore grant opportunities, even if they do not qualify under the criteria listed below.

Alliss Grant Criteria:

- Grant recipients must be ***out of school for at least seven years.***
- They may be first-time community college enrollees who ***graduated from high school at least seven years ago, or former college students who haven't been in college for seven years.***
- Recipients must ***not hold baccalaureate or higher degrees.***
- They must be ***legal Minnesota residents;*** those with reciprocity status are not eligible.
- Students ***already receiving financial aid or subsidized credit are excluded*** from the program.

Adult Learner Grant Criteria:

- Grant recipients ***must have completed 30 credits*** and ***must have been away from college for three or more years.***
- They must be ***over the age of 25.***
- They ***must have completed a FAFSA application.***
- They ***must have a cumulative GPA at Anoka-Ramsey Community College of 2.0 or higher.***

NOTE: The College is asking you to provide information which includes private and/or confidential information under state and federal law. The college is asking for this information in order to process your application.

You are not legally required to provide the information the college is requesting; however the college may not be able to effectively process your application if you do not provide sufficient information. With some exceptions, unless you consent to further release of private information, access to this information will be limited to school officials, including faculty who have legitimate educational interests in the information. Under certain circumstances, federal and state laws authorize release of private information without your consent:

- To other schools in which you seek or intend to enroll, or are enrolled, if you are first notified of the release;

- To an institution engaged in educational research or accrediting agency.
